MOVING FORWARD IN THE COMMUNITY

In 2015, The Edinburg Center successfully opened a four bedroom home in Westford for four women with brain injuries. Over the course of the past two years, these women have made extraordinary progress as they transitioned from living in a nursing home to maintaining a rich happy life in the community.

This home is located near conservation land that includes beautiful views of a pond and an abundance of natural greenery. The Center renovated the house to meet the needs of each person. The halls were widened, bathrooms were adapted and new doorways were installed in two bedrooms to connect to the outside wrap-around deck so that everyone could safely evacuate in case of an emergency.

At a recent meeting with the Massachusetts Department of Developmental Services, our Westford program was described as a “Best Practice” program because of the care we provide and the design of the physical site. We have even been told that the large bathroom and shower are the envy of other providers in the Northeast!

“Over the course of this past year, each individual has made extraordinary progress transitioning into this home with the support of a dedicated and caring staff and positive connections with friends and family. When one person initially came to the program, she was not able to stand or walk. She is now walking with the aid of a walker. Another individual previously communicated by using a thumbs up or down response. Today, this person can speak, is able to answer questions and says grace before meals. A family member recently told us that his daughter is the happiest she has ever been – even before her injury.”

3-D DIVERSITY LUNCHEONS

CELEBRATING, SHARING AND LEARNING

The Edinburg Center's Diversity Task Force works towards ensuring that The Center is sensitive and responsive to the needs of the individuals and communities we serve, as well as, to the staff who are employed by our organization. Over the years, the Diversity Task Force has conducted diversity surveys, provided trainings for all staff and reviewed/modified related agency policies. In addition, the Task Force sponsors a very popular luncheon series called the *3-D Diversity Luncheon (Diverse-Delectable-Dining)* that focuses on learning about other cultures from people who work at The Center.

Some of the countries featured at past 3-D Luncheons have included China, Haiti, Rwanda, England, Tanzania, Uganda and Zimbabwe. Many staff have commented about how interesting it is to learn first-hand about another country from other staff, as well as, sample delicious foods and listen to music from a variety of countries.

This past year, the focus of our 3-D Luncheon presentation was "On Being a Muslim". An overflowing crowd of over 200 Edinburg Center staff were in attendance. This presentation proved to be an excellent opportunity to learn more about being a Muslim in the United States and as an employee at The Edinburg Center. Our staff also presented information about Islam, obligatory prayers, clothing, cooking, peace vs. violence and a discussion about Islamophobia.

Over the years, our 3-D Diversity Luncheons have helped to make us aware of the rich cultural diversity that our staff brings to The Center. We are looking forward to future luncheons not only to learn more about other countries and cultures, but to also learn more about each other through knowledge and sharing personal experiences.

ELECTRONIC HEALTH RECORDS

TRANSFORMING SERVICE DELIVERY

In 2009, Congress established the adoption of Electronic Health Records (EHR) in the health care system as a critical national goal. Electronic Health Records will ultimately increase the ability of organizations to exchange health information electronically and help them provide quality and safer care to the recipients of their services.

The Edinburg Center has been in the forefront of implementing Electronic Health Records. In 2009, an agency-wide steering team was appointed to lead this initiative which included a thorough selection process to choose an EHR system, working with a consultant to comprehensively plan for The Center's EHR implementation and the completion of a Train the Trainer Curriculum for key staff.

Since that time, The Center has systematically implemented Electronic Health Records for our services and is scheduled to bring all of our programs onboard by the end of 2016. Major implementation steps along the way have included staff training, system customization, adding clients and staff into the system and addressing start-up issues. Other recent accomplishments include completing the accounts receivable/billing capacity and implementing prescribing and lab order software that streamlines administrative processes while also adding safety features.

In addition, The Edinburg Center was awarded a \$50,000 Massachusetts eHealth Institute eQuality Incentive Program grant to support the expansion of our EHR system. Key goals for this grant included implementing a client portal for our EHR system and sharing medical records electronically with hospitals and other EHR providers.

This past year, we continued to move forward to improve the functionality available in the EHR system which included automated tracking of key dates for clients, treatment plan due dates, the development of an incident reporting system, utilizing the system for appointments and streamlining the outpatient services process.

As you can imagine, the implementation of Electronic Health Records has been an enormous task on a multitude of levels. We appreciate the dedication and hard work that has ultimately resulted in an EHR system that enhances the privacy and security of client data, provides accurate, streamlined documentation and improved communication and the coordination of safe care for the individuals we serve.

The Edinburg Center's Development Team was honored at the Netsmart Connections 2015 Conference for excellence in implementing the Healthcare IT Value Model.





A Night of Shining Stars

RECOGNIZING AND CELEBRATING EXCELLENCE FOR OVER 15 YEARS

The Center's annual recognition event, "A Night of Shining Stars", formally acknowledges the exceptional accomplishments of the people we support, our staff and community friends of the agency. This past year we reached a special milestone – our fifteenth celebration!

Since 2001, this unique event has included not only the participation of our staff, but also the people we support, in both the nomination and selection processes. Approximately 3-4 months before the event, Star Search Nomination Forms are available to everyone affiliated with The Center. After nominations are submitted, the Selection Committee (comprised of Shining Stars from the previous year) meets to review over 100 nominations and select the current year's Shining Stars award recipients.

Our "Shining Stars" have demonstrated many positive attributes such as:

- Demonstrating significant individual personal or professional growth
- Exceeding expectations / going above and beyond his / her role
- Providing leadership and motivating others
- Acting as an outstanding role model to peers
- Initiating new and innovative service ideas
- Contributing to the advancement of individuals served by The Center
- Improving morale, being an inspiration and/or having a positive influence on others

Our event also includes the presentation of a number of special awards which exemplify the positive attributes of individuals who have made an impact on The Center. These awards include the Golda Edinburg Leadership Award, the Jack Breneus Direct Service Award, the Carolyn Meybaum Direct Service Award and the Claire Boudreau Family Award.

A recent addition to the evening's program has been to showcase our newest videos beginning in 2013 with "A Pioneer with a Purpose" - a special tribute to Golda Edinburg. Since that time, a number of videos focusing on our programs and individual recovery stories have premiered at our Shining Stars event. INVESTING IN THE FUTURE THROUGH ADVOCACY

One of the primary goals of The Edinburg Center is to advocate for key issues that affect The Center and the people we support. As part of this effort, The Center's Advocacy Task Force works in a variety of ways to achieve this goal through ongoing communication with our legislators to discuss the fiscal and programmatic challenges that face our organization. We also invite legislators to tour our programs so that they can meet with our staff and the people we serve to learn more about their lives and how public policies affect them on a personal level.

In addition, the Task Force works with other local human service provider agencies to organize the annual Metro-Suburban Advocacy Initiative East Legislative Breakfast in May. Commemorating "May is Mental Health Month", this well-attended event includes the participation of legislators, consumers, family members and staff and gives the individuals we serve the opportunity to meet face to face with their local state representatives.

On a statewide level, The Center's Management Team actively serves in a number of key leadership positions with a variety of organizations including the Association for Behavioral Healthcare, the Association of Developmental Disabilities Providers, The

Providers Council and the Massachusetts Psychiatric Rehabilitation Association. In addition, The Center's Family Advocacy and Support program collaborates with the Massachusetts National Alliance on Mental Illness (NAMI) and provides additional opportunities to engage families in support and advocacy initiatives.

The Center also participates in advocacy efforts on a national level. Last year, our CEO, Ellen Attaliades, traveled to Washington DC to attend the National Council for Behavioral Health's "Hill Day" - the largest behavioral health advocacy event of the year. Over 600 behavioral health providers, administrators, board members, consumers and community stakeholders listened to experts in the field and attended sessions and workshops on federal behavioral health policies. Along with other Hill Day attendees from Massachusetts, Ellen had the opportunity to meet with Senator Elizabeth Warren and Senator Ed Markey to make the case for supporting mental health and substance use legislation and funding.

The Edinburg Center understands how important it is to communicate on local, statewide and federal levels to share our stories, as well as, our concerns and challenges so that we can ultimately provide the people we support with the services that they need to live a full life.
